Housing and Homelessness Program RRI completed the 25 Cities Initiative in September 2016 aimed at helping the 25 largest cities in the US make significant progress towards ending homelessness among veterans in their respective communities. The program was sponsored by the U.S. Department of Veterans Affairs, the U.S. Department of Housing and Urban Development, and the U.S. Interagency Council on Homelessness. According to the Acting Director for Homelessness Services at the VA, the number of veterans experiencing homelessness in the 25 cities was reduced by 47%, compared to a 27% reduction in other cities that were not part of the initiative. RRI also launched 100-Day Challenges focused on ending youth homelessness in Austin, Cleveland and Los Angeles. During the 100 days, a total of 426 youth and young adults experiencing homelessness in the three cities were connected to stable housing and each city built a coordinated system for assisting youth experiencing homelessness. This effort was heralded by HUD and HHS leaders as the jump-start of a national campaign for ending youth homelessness by 2020. RRI will continue to support that campaign with additional 100-Day Challenges in 2017 and beyond.

Integrated Social and Health Care Program RRI continued our partnership in 2016 with NESTA, the premier social innovation foundation in the UK, to further accelerate innovation in the health sector there. The program we developed with Nesta, People Powered Results, was picked up as a best practice by senior leaders at UK's National Health Service. In 2016, we helped these leaders use the program to develop and test new models to better integrate social care and health care with the goal of reducing overall demand for elective care services. The models emerged out of our 100-Day Challenges in Stockport and Harrogate. These models are now being rolled out nationwide through a learning collaborative that we helped the NHS establish at the end of 2016 Government Accelerator Program. In late 2016, RRI launched a collaboration with the Prime Ministers Office of the United Arab Emirates to build a Government Accelerator powered by RRI's 100-Day Challenge choreography. The aim of the Accelerator is to infuse an entrepreneurial spirit into the way Government ministries approach service delivery and to accelerate progress towards achieving the country's vision 2021 goals in the areas of health, education, environment, safety, happiness, and economic innovation. Six teams launched towards the end of the year and RRI began an extensive training program for local coaches who will continue to work out of the Prime Ministers Office. Our aim is to refine this model for helping Government teams deliver faster results while building capacity for cross boundary collaboration, innovation and execution, and adapt the model to countries in sub-Saharan Africa and possibly other countries in the Middle East.

Training and Technical Assistance RRI completed a comprehensive nine-month training and certification program for Rapid Results coaches with the Government of the Democratic Republic of Congo. Thirteen of the twenty program participants have been certified as coaches capable of supporting Rapid Results teams and leadership. RRI also launched six 100-Day Challenge teams in Nigeria, working with the Federal Ministry of Health. The focus is to accelerate service delivery to the poor including delivering simple surgeries for free, supplying nutrition kits to displacement camps in the Northeast region, and revitalizing primary care centers around the country. According to an interview on local media with the Federal Minister of Health, significant results have been achieved by several of these teams including 4,349 free surgeries, 17,793 health screenings, and the delivery of 200,000 nutrition kits to displacement camps.
