1 Youth Homelessness in the US We jump-started a national campaign to end youth homelessness in the US We worked with 11 communities (Los Angeles, Cleveland, Austin, Hennepin County, Palm Beach County, Baltimore, Columbus, Louisville, Seattle, Spokane, and Pierce County) to launch and support youth homelessness 100-Day Challenges During the 100-day period of these Challenges, these 11 communities enabled 1714 youth and young adults experiencing homelessness to move from homelessness to safe and stable housing In each community, representatives from all organizations and local agencies involved in supporting young people at risk of or experiencing homelessness came together in their 100-Day Challenge and created systems of coordination that target youth with the most acute needs and direct appropriate resources and services to them In almost all cases, the results were achieved without adding any new resources into the system The impact was created through collaboration, innovation and rapid and disciplined execution The impact in each community continued beyond the 100 days, with sustained higher performance on the critical indicators (such as monthly housing rate), as well continued expansion and strengthening of the coordinated systems We did this work in partnership with and support from A Way Home America, National Alliance to End Homelessness, Home Base, and with funding from the Department of Housing and Urban Development, Department of Health and Human Services, Melville Charitable Trust, Raikes Foundation, Jim Casey Foundation, and Schultz Family Foundation 2 Criminal Justice System in Mexico We started a program in Mexico to operationalize the reform of the criminal justice system so there is impunity of perpetrators of crimes, justice for victims, and security for citizens In 2017, we launched 100-Day Challenges in six cities in three states These were partially completed in 2017 and were showing signs of huge lifts in key indicators of system performance in each city such as rate of resolution of pending cases In each city, teams comprised of judges, defense attorneys, prosecutors, police, businesspeople, and reps from advocacy groups (e g victims of domestic violence) formed teams that set their own 100-Day goals and innovated their way to achieving these Importantly, collaborating on these 100-Day Challenges transformed the relationship between these groups, and built trust and camaraderie between all those involved In line with our mission, we trained 20 local facilitators to support us in the delivery and to build the infrastructure for scaling this work The 100-Day Challenges got the attention of leaders in the judicial system and funders, and the program grew into nation-wide movement in 2018 We did this work in partnership with the ProJusticia program team (part of Management Systems International), with funding from the United States Agency for International Development 3 Government Accelerators in the UAE We worked with the Prime Ministers Office of the UAE to establish a Department for accelerating progress on citizens services and on the initiatives and programs related to the countrys Vision 2021 At the core of this Department is the use of RRI 100-Day Challenges to inspire teams from across Government and the private sector to collaborate and innovate at unprecedented levels, and to execute at a breathtaking pace Some of the results achieved during the 100-Day Challenges included Reduced road deaths on the 5 most dangerous roads in the UAE by 63% over the same 2-month period the prior year The effort was led by the Ministry of Interior Reduced emissions from the EGA Aluminum factory by 16% in 100 days, equivalent to annual emissions of 460,000 cars The effort was led by the Ministry of Climate Change Screened 2,201 women for breast cancer in the Emirate of Fujairah, in 100 days compared to 1,200 in the full year prior The effort was led by the Ministry of Health In line with our mission, we trained 20 Emirati professionals that work at the Prime Ministers Office to become coaches and facilitators of 100-Day Challenges Most of these were women, something we take particular pride in, especially given the highly patriarchal cultural context These coaches continued to design and support 100-Day Challenges after our team left the scene, and the UAE Government Accelerators is now on a must visit for senior Government officials visiting Dubai from other countries in the region and outside
